"This aircraft is ideally suited for offshore operations, with its reduced fuel consumption, ability to use up to 50% blended SAF, spacious cabin and excellent cockpit visibility. The twin-engine Airbus H160, one of the world's most innovative medium-sized helicopters, offering the capacity of up to 12 passengers and a range of 890 km (480 NM) with standard fuel tanks. The H160 exceeds the requirements of the latest and most demanding regulations (EASA CS-29 certification standards) and the most stringent guidelines from the International Association of Oil & Gas Producers (IOGP 690 and CAP best practices).

With this introduction, OHI, through its affiliate Omni Táxi Aéreo, becomes the first operator in Latin America to offer the Airbus H160 to its customers in the offshore energy sector.
